SECTION 5. FIRE FIGHTING MEASURES

SECTION 6. ACCIDENTAL RELEASE MEASURES

Wear protective gloves, chemical goggles and safety boots. Wipe up residue with a cloth. For large spills contain and collect with inert absorbent materials (e.g. sand, earth, vermiculite). Transfer to sealable containers suitable for storing spilled material. Flush areas in contact with spilled material with adequate warm soapy water to render the area safe for human contact.
